My name is Dave and I'm an alcoholic.

I came to AA in 1990 after many years of suffering and misery. I had finally (thank God) hit a bottom low enough to be willing to honestly try what I had always avoided: to listen, take direction, and do what I was told.

I got a sponsor with whom I worked the steps, went to a lot of meetings, and made myself available to help other alcoholics when I could.

Miracle of miracles, I stayed sober. All those people who saved me, my sponsor, family, all the people in the meetings, were working the 12th Step on me. Through them and the work I did through the steps, I have awakened to a spiritual way of living and believing that I never knew existed. My obligation is to share with others the way they did with me. The meetings are where I learned the principles. Life outside is where I have to live them--an act of kindness, a ride to a meeting, sharing at a meeting, just listening to someone. 12th step work has many forms.

I do some service work, I've sponsored people, I have a home group where I participate. For me, it's all part of carrying the message and it keeps me sober. So much of what I've learned is from the examples others have shown me. I can believe what someone is teaching me when I see them living it. I was told once that the first thing I had to do to help another alcoholic was to stay sober. I have to be an example. I cannot give what I don't have and if I'm not living it, I don't have it.

Thanks to the people who 12th stepped me I am alive and have a way of living that gives me something worth sharing, and the willingness to do so. I am never more firm in my recovery than when I'm telling another alcoholic that he too can recover and I will help, if he wants me to.

I am so grateful to those who told me and showed me what they did.

Thank you for my recovery.



A.A. TRADITIONS AND THE INTERNET

We observe all A.A.'s principles and Traditions on A.A. public media such as the Internet.

Anonymity — As anonymity is the "spiritual foundation of all our Traditions," we observe anonymity on public websites at all times. In 2013, the 63rd General Service Conference affirmed that "the Internet, social media, and all forms of public communications are implicit in the last phrase of the short form of Tradition Eleven, which reads: '...at the level of press, radio, and films.'" As Bill W. wrote: "At this altitude [public], anonymity — 100 percent anonymity — was the only possible answer. Here, principles would have to come before personalities without exception." In simplest form, this means that A.A.s do not publicly identify themselves as A.A. members using their full names and/or full-face photos. For more information on anonymity online, see the section of this Guideline, "Guarding Anonymity Online." **Attraction not promotion** — As our co-founder, Bill W., wrote: "Public information takes many forms — the simple sign outside a meeting place that says 'A.A. meeting tonight'; listing in local phone directories; distribution of A.A. literature; and radio and television shows using sophisticated media techniques. Whatever the form, it comes down to 'one drunk carrying the message to another drunk,' whether through personal contact or through the use of third parties and the media."

Self-support — In keeping with our Seventh Tradition, A.A. pays its own expenses and this also applies in cyberspace. To avoid confusion and to guard against the perception of affiliation, endorsement or promotion, care should be taken in selection of the website host. Website committees have avoided any host site that requires the inclusion of mandatory advertising space or links to commercial sites. Many "free" web hosting services require that the website include mandatory advertisements or links. Most A.A. website committees see this as actual or implied affiliation or endorsement of the products or services listed in those ads. They have found it prudent to create a website through a service that does not include mandatory advertisements or links.

Nonaffiliation, nonendorsement — linking to other A.A. websites will often have the positive effect of significantly broadening the scope of a site. However, even when linking to another A.A. site, care must be exercised since each A.A. entity is autonomous, has its own group conscience, and may display information that another A.A. group conscience might find objectionable. There is no way to know when this might occur. Experience indicates that linking to non-A.A. sites is even more problematic. Not only are they much more likely to display non-A.A. and/or controversial material, but linking might imply endorsement, if not affiliation. In the final analysis, experience strongly suggests that, when considering linking to another site, proceed with caution. G.S.O. has attempted to avoid some of these pitfalls on G.S.O.'s A.A. website, aa.org, by confining its links to known A.A. service entities and by incorporating a mandatory exit statement when someone wishes to activate the outside links on the site. (This statement also covers access to application software such as Adobe Reader, which is provided to assist visitors in reading Portable Document Format (PDF) files.)

GUARDING ANONYMITY ONLINE

Modern communication in A.A. is flowing from one alcoholic to another in ways that are high-tech, relatively openended and evolving quickly. Protecting anonymity is a major concern for members, who are accessing the Internet in ever-growing numbers. As Bill W. noted, "Anonymity has two attributes essential to our individual and collective survival; the spiritual and the practical. On the spiritual level, anonymity demands the greatest discipline of which we are capable; on the practical level anonymity has brought protection for the newcomer, respect and support of the world outside, and security from those of us who would use A.A. for sick and selfish purposes." When we use digital media, we are responsible for our own anonymity and for protecting that of others. When we post, text, or blog, we should consider whether we are publishing at the public level. When we break our anonymity in these forums, we may inadvertently break the anonymity of others.


Anonymity is considered the single greatest protection that the fellowship has to assure its continued existence and growth. Looking at the history of AA, from its beginning, it is clear that anonymity is vital for our program to continue in order to be a safe place for the alcoholic to rest their weary mind and body. We usually think of anonymity at the public level of press, radio, TV, films and other media technologies such as the Internet. But what about anonymity at the personal level?

Personal anonymity is the basic foundation in protecting all members from being identified as alcoholics outside of the rooms. A sponsor's promise to keep information about the newcomer's stories is a life-or-death promise for the newcomer. Without this unspoken oath of confidence, the 5th step would be impossible for most of us. This trust has been so precious in my sobriety and should never be taken lightly. I have personally experienced this break in trust and it took a lot of prayer to recover from it. Having this trust disregarded and my personal anonymity broken could have caused a relapse without the love and guidance from other trustworthy members and a power greater than myself. This safeguard of confidentiality allows us to share the most intimate, painful, details of our lives with our sponsor without worry of gossip or judgement from others. This is the first lesson in anonymity. Whether we are in a meeting or working with a newcomer we need to remember "What we hear here, when we leave here, Let it stay here! Period. Other sponsee's, sponsors, or friends should never hear the details we have learned of other members stories. This disease is life or death and our program is a safe place to recover and not to be taken lightly. If we can remember to stay AA members and not be AA show offs our program will continue to be a Safe Harbor for the alcoholics who still suffers, inside and outside of these rooms.

And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance, it reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all (12x12 pg 192)
